**6:30PM: Public Hearing regarding rezoning of 1101 High Street**

**PLEDGE OF ALLEGIANCE & PRAYER:**

The meeting was called to order @ 7:00pm and opened with the Pledge of Allegiance and a prayer led by Councilmember Bruce Fackler.

**WELCOME GUESTS:**

Mayor Pace welcomed guests to the meeting, then introduced the 3 new Councilmembers. He then listed the reappointment of the Police Chief-Brian Haag, City Clerk Treasurer-Amy Haynes, and City Fire Marshall-Chris Crawford.

**RESOLUTION 2024-07:**

Mayor Pace read aloud a resolution in memory of previous City Fire Marshall Larry Naser. A motion was made by Bruce Fackler, seconded by David Woodward, to accept the resolution as read. Vote of motion was unanimously approved.

**PLANNING & ZONING:**

City Attorney Roberts read aloud Ordinance #646 – the rezoning of 1101 High Street. A question was asked as to how far the buffer would be between Mrs. Pollock's home and the new road. City Engineer Tim Smith stated that it was approximately 500 feet. A motion was made to approve the rezoning by Bruce Fackler, seconded by Mark Spry, the motion passed with Fackler, Spry, Allen, Woodward, and Wiles voting yes, and Brown voting no.

**APPROVAL OF MINUTES:**

A motion was made by Bruce Fackler, seconded by Mark Spry, to approve the minutes of the 12-09-2024 regular meeting. Vote of motion was unanimous.

**TREASURER'S REPORT:**

The transfers were read aloud by Shannon Stull. A motion was made by Mark Spry, seconded by David Woodward, to approve the transfers as read. Vote of motion was unanimous.

Councilmember Woodward asked what the interest rates were on the MRA Account, as well as the LGEAF account. Councilmember Brown asked that the deposits be more descriptive, as in what does it mean when it states "split". She also asked for a list of all employees as well as C.O.P members.
